A Study of Sexual need and Emotion among Patients with Major Psychosis in Taiwan

The purpose of this study is to investigate the relationship between sexual needs and emotional state in psychiatric patients, the object of study in a regional teaching hospital psychiatric inpatients in Taiwan, with diagnosis of schizophrenia and severe major depressive disorder, by of DSM-5 in patients with mental disease. This study approved by Institutional Review Board of the party, the subsequent results case study. A cross-sectional design was performed. Three structured questionnaires which contain personal backgrounds, sexual needs and coping emotional state were administered to full-time in patients with acute and chronic ward by purposive sampling total of 162 cases. Descriptive statistic, one way ANOVA, Pearson's correlation coefficient, and stepwise multiple regression were used to analyze the data. The "sexual needs" of the mental disorders with different background variables in the "gender", "age", education, marital status, There are significant differences in the disease name, hospital type, hospital stay, time to go out in hospital, and age of on set. The emotional state of the mental disorder of different background variables in the "marital status", There were significant differences in hospital type, hospital stay, and time to go out in hospital.

And the message of hypersexualized female is obvious. It becomes invisible and encourages the normalization of materialized female. Since childhood, female has been educated with the ideal body and appearances that cater to the male eyes. Nowadays, the media actively constructs the beauty of the female body and becomes a part of social culture. It also forms a single imagination and norm of the female body, which in turn leads female to have unrealistic attitudes and displeasure toward their body image.

When exposed to messages of materialized and hypersexualized female, female should ask themselves what they see, what they feel, and give self-value clarification to help them have reasonable and realistic expectations for their body image. And along with independence and awareness of the female, they must bravely see what is in front of them and question the practices and norms that are considered normal and acceptable. And female can empower their body through different sports, body activities or careers, etc. to show multiple body types and manifest the ability of physical autonomy and self-determination, which will promote changes to the existing values of society for female.

How does one 'choose' to become a pimp?
An Examination of the factors and motivations that influence *becoming* a pimp

Based on in-depth interviews with nine pimps involved in illegal street prostitution in this USA, this paper will examine the experiences and factors that led respondents to exposure, choices and training in pimping; all leading up to their entry into this illegal career. Through exploration of the motives and variables that impacted respondents prior to pimping, it is possible to shed light on *why* and *how* an individual might chose to take up this maligned role: to *become* a pimp. This project sought narratives of personal background histories prior to entry into pimping; these histories were placed within American ghettos. Therefore, this paper will first briefly describe the socio-spatial environs of the American hyperghetto ('the jungle' or 'the ghetto'). The importance of exposure to the world of pimping will then be highlighted; data indicated that the visibility of pimps in one's community and informal presentation of pimping culture was vital. Respondents' involvement in other illegal activities, or gateways, led to locations and sites that proved to attract hustlers involved in various underground economies. Through these gateways, respondents became active in a wide breadth of illegal hustling activities. As a result, respondents often acquired lengthy criminal records. Respondents with criminal records, especially those marked by felonies, met a significant reduction in opportunities for education and legitimate employment. Thus respondents saw entry into an illegal career as their only option to access the status, respect and income they sought. Once determined to become a pimp, learning The Game (the world of pimping and prostitution) and becoming familiar with those locally involved was crucial. Thus the final section will describe the apprenticeships and training individual underwent from older, more experienced pimps. This process of training is explored as a characteristic of this subculture that values the passing on of information on The Game through generations.

Background: This article comes from the perspective of HIV case manager who has the most interaction with people living with HIV(PLWH). As the Practical workers in public health, we experience the conflicts between administer of public health and PLWH in Taiwan', this proposal is try to present what the conflicts is and how its workers.

Methods: Action research and narrative method. through the practical working experiences to record the sexuality of PLWH under Taiwan 's public health policy and laws. The data was collected by notes and other documents.

Results:1. PLWH is not only afraid to had an intimate relationship, but also treat themselves as: "Not deserved" to have a relationship. 2.the specific law "HIV Infection Control and Patient Rights Protection Act" in Taiwan, which has restricted limitation for PLWH's sexuality.3. both the prevention policy in public health but the sexuality for PLWH are influence by stigma.

Conclusions: Either prevention policy or specific law in public health have to be modify. As Case manager, our practical experience is based on the subjectivity of PLWH, we need to keep communicating with policy makers. decrease the impact of HIV/AIDS stigma.

The purpose of the study is to explore sexual attitude of sexual-bullied students, and the role of the teacher to the bullied in sexual-bullying events. A qualitative research method is adopted to in-depth interviewing three male sexual-bullied students. The interviews were conducted one or two times and each for about one hour. The result is analyzed by the narrative analysis method. The main findings are as follows:

(1)Evading and being indifferent are often taken as the best strategies by the sexual-bullied, and the stress sexual-bullyings brought to the bullied caused the fear of going to a toilet and going to school, which resulted in the seriously physical or mental pain .(2)Sexual-bullying brought the bullied the self-detestation of their own femininity and sexual organs.(3)The sexual-bullied students expected not to be divided into groups by gender as the category and expected teachers to deal with sexual-bullying events.

Based on its main findings, this study proposes specific recommendations to serve as reference for parents, researchers, educators, administrators, and policymakers.
